The Elizabeth Inn Program provides emergency shelter for men, women and
families living in homelessness. Our program connects the client to
MUST Workforce Development for resume writing and career building
opportunities. Each client is assigned a case manager for weekly
planning meetings to develop a Housing Stability Plan indicating their
program goals and addressing possible barriers to housing. In addition,
the client receives appropriate referrals to mainstream services for
concerns such as mental and physical health, substance abuse and
domestic violence. In the past 12 months, 722 clients have successfully
entered a Housing Stability Plan after receiving placement in our
program. This total represents 91% completion toward our annual goal.
Additionally, 441 clients completed one goal toward self-sufficiency
(obtained employment, obtained a mainstream benefit or qualified for

housing). This total represents 147% completion toward our annual goal.

Notably, 549 clients have graduated from the Elizabeth Inn Work

Recovery program and received stable housing, representing 122% of our annual goal.

MUST Ministries' Supportive Housing Program addresses the needs of persons with mental and/or physical disabilities and substance abuse who are chronically homeless. As of the 2018-2019 fiscal year, the Supportive Housing Program has served 131 individuals with case management, medical assistance, education (GED Program) and employment services. These services are rendered through the Supportive Housing Programs in Cobb, Cherokee and the Veterans Program in Marietta.

Through these programs our goal is to help individuals move toward self-sufficiency with stable housing, education, employment and financial benefits.

MUST can serve those who are living in homelessness or who are facing eviction through several federal grants. The BoS Rapid Re-Housing (RRH), funded by the Balance of State Continuum of Care, is a program for individuals/families who are living in homelessness and meet the income limits of 50% or below AMI. This program housed clients in Bartow, Cobb, Cherokee, Douglas, Paulding and Pickens counties. A total of 56 individuals were served in this program. Of the 56 individuals served, 88% were stably housed upon completion of the program. The Cobb Rapid Re-Housing (RRH), funded by Cobb County CDBG program, is a program for single individuals who are living in homelessness and meet the income limits of 30% or below AMI. This program housed clients in Cobb County. A total of 25 individuals were served in this program. Of

the 25 individuals served, 90% were stably housed upon completion of the program. The Tenant Based Rental Assistance program, funded by Cobb County HOME program, is a program for families and seniors who are living in homelessness or at risk of becoming homeless and meet the income limits of 80% or below AMI. This program housed clients in Cobb County. A total of 53 individuals were served in this program. Of the 53 individuals served, 94% were stably housed upon completion of the program.

MUST Ministries Marketplace is our clothes closet where our customers can come in and receive a clothing allotment for the year for their entire family. Families can come in once a month to shop for clothing in our Marketplace where we have racks and displays of clothing. Marketplace is setup just like a regular department store which gives our customers the experience of shopping, all their clothing items are free. We also carry household items and furniture at discounted Thrift store prices. In July 2017 - June 2018 our retail sales were \$171,000 in July 2018 - June 2019 our retail sales were \$224,713. Revenue we make through the Marketplace goes back into MUST Ministries to support and run our Programs.

MUST Neighborhood Pantry operates food pantries in 38 schools (32 Cobb County Schools, two Marietta City Schools, one at Kennesaw State University and 3 in Cherokee County) serving 350 families in a typical month. The students are identified by a liaison who is either a school social worker, guidance counselor, or academic coach, focusing on students who are most at risk: homeless children and families,

households with children that have been abandoned by their parents, special needs children and families, families with life-altering illnesses, families with recent unemployment and the working poor. 3,901 clients were served in 2018-19, and 263,337 pounds of food distributed. On a monthly basis, each family receives approximately 75 pounds of food and toiletries. The pantries have expanded rapidly and currently serve more than 2,100 students and their families. More pantries are being added.

Expenses \$ 903,780. including grants of \$ 476,108. Revenue \$ 224,712.
