



## **Texas Renaissance Festival – Fields of New Market Campground Vendor Application Information**

The Texas Renaissance Festival offers its patrons unique quality services and products. TRF is the largest Renaissance theme park in the United States attracting more than 450,000 patrons each year. Guests are transported back to the 16<sup>th</sup> century to experience world-renowned entertainment. 2020 Festival season dates are nine consecutive weekends from October 3<sup>rd</sup> through November 29<sup>th</sup>, including the Friday after Thanksgiving. Each week during the Festival season, The Fields of New Market Campground is open from Noon Thursday until Noon Monday.

Please complete the vendor application and include it with your proposal. The proposal should be bound or in a binder, contain pictures and prices of all of your products, a brief bio about yourself and/or your business, and a listing of any faires, festivals, or events you have done or will be doing this year. Samples of your products or wares are encouraged but will not be returned. Mail the completed submission to TRF, attention Vendor Manager - Campground, 21778 FM 1774, Plantersville, Texas 77363. Applications will be accepted for the 2020 Festival season between November 1<sup>st</sup>, 2019 and August 1<sup>st</sup>, 2020.

A \$50.00 non-refundable application fee made payable to TRF must be included with the proposal. Submissions received without the fee will not be accepted or returned.

All merchandise, services, and food/beverage menu items will need to be approved individually. All applicants will be notified, in writing, of your acceptance or denial. Items not approved by the jury will not be allowed to be sold at the festival. TRF will not approve items or services currently offered within our festival grounds. Food and beverage items are an exception. Food vendors must show training and health certification, and anyone selling alcohol must be TABC certified.

Structures must be approved by TRF Management.

If accepted to TRF you will receive a packet containing our rules & regulations, your acceptance letter, a map with your location clearly marked, and your contract. You will have approximately 30 days to pay your vendor fees. The contract we offer becomes null and void if your required fees are not paid within the allotted time.
